

Both On-Site and At-Home Video Visitation Is Now Available!

The Sanpete County Jail recently upgraded the video visitation program to allow for two options for visiting an inmate: free public visitation done at the Sanpete County Jail and at-home visitation that can be done from any mobile device or computer with a fee.

Visitation Information and Rules:

- Visitors will have the option of coming to the Sanpete County Jail for a free on-site visit, or may opt to create an account and have the ability to visit remotely for a fee.

On-Site Visiting Hours and Limitations:

- 10:00 am to 6:00 pm, Monday – Friday
- Visitors will need to schedule on-site visits at least **3 days** in advance. This can be done by going to <https://securustech.net>. Choose the “Video Services” tab at the top of the page and then follow the directions to schedule your on-site visit.
- Visits may be denied due to facility operations issues, security threats, etc. Visits will not be allowed if active protective orders, stalking injunctions, etc. exist between the visitor and the inmate. Inmates will not be allowed to visit with victim(s) or anyone involved in court cases.
- Visitors may not visit if they were incarcerated within 45 days of the visit.
- Visitors under the age of 18 must be accompanied by their parent or legal guardian.
- Visitors over the age of 16 must present a photo ID before beginning the visit. For visitors 16 -18 years of age, this may be a school ID card or other similar type of ID. For visitors 18 years and older, the photo ID must be a valid government document: i.e., driver’s license, state ID card, passport, etc.
- Parents must be in control of their children at all times. Do not allow children to play on stools, visiting kiosks, etc. Parents who fail to maintain control of their children may be asked to leave the visiting area.
- No food or drink is allowed in the visiting room.
- No cell phones are allowed in the visiting room.

Remote Visiting Hours and Limitations:

- 8:00 am to 9:00 pm, 7 days a week. Please check online visiting schedule for availability.
- One visiting period per day, up to 7 visits per week. Visiting periods may be twenty to forty minutes long. Fees do apply for remote visiting.
- Prior to scheduling a remote visit, individuals must go to the Securus website at <https://securustech.net> to complete on online application. Once this application has been

approved by the Sanpete County Jail, visitors may schedule their remote visits through the same website. The application approval could take up to 3 days.

- The Securus account holder must be present at the beginning of each remote visit.
- Only the Securus account holder may be present during the visit unless prior arrangements for other visitors have been made through the Sanpete County Jail Visitation Coordinator.
- Visits will **NOT** be allowed between visitors and inmates who have active protective orders, stalking injunctions, etc. Inmates will not be allowed to visit with victim(s) or anyone involved in court cases.
- Fees paid for remote visits are non-refundable. The jail is not liable for lost funds due to visits that did not occur due to security issues, disciplinary issues, etc.
- Failure to follow rules set by the Sanpete County Jail may result in a person's online account being denied.

Rules for both On-Site and Remote Visits:

- Visitors and inmates may not engage in sexually explicit behavior. This includes nudity, sexually explicit conversation/hand gestures, etc.
- Visitors are required to be fully clothed and may not wear sexually suggestive clothing. This includes see-through clothing, etc.
- Any communication that is deemed to threaten the safety and security of the facility (information on transports, movements, etc.) will result in the visit being terminated.
- No foul, abusive, threatening, or unreasonably loud language. Visitation may be suspended or terminated.
- Visitors who violate rules with regards to visiting will have their visiting privileges suspended. Visiting is not an unfettered right, and as such, visitors who violate rules can have their access to the visiting program suspended indefinitely.

Inmate Phone Calls:

- Inmates can make outgoing calls.
- All inmate outgoing calls are either collect or pre-paid using purchased phone time. Inmates are able to purchase phone time to make non-collect phone calls.
- Family and friends have the option of setting up an account through Securus (see number below) and have received calls charged to that account.
- If you do not wish to receive calls from an inmate, you can put a block on your phone so that they are unable to call you. This can be done by speaking with a member of jail administration (435) 835-2192.
